Terms and Conditions for Engagement of Professionals on Fixed-Term Tenure Basis

Criteria for Engagement

- 1. The engagement of tenure-based personnel may be for the required duration but shall not exceed a maximum of three years from the date of engagement, subject to satisfactory performance and annual review. The tenure will automatically terminate upon completion of three years from the date of joining, without any further notice. The employment may be terminated at any time during the tenure by either party, by giving one month's notice.
- **2.** Applications received after the due date will be rejected.
- 3. Candidates who are shortlisted for interview, written test, or presentations (depending on the position requirements) will be required to bring original documents/testimonials, along with self-attested copies, in support of age, qualifications, experience, etc. The certificates will be verified by a designated HR officer before the candidate is permitted to attend the interview, as detailed below:
 - (a) Documentary proof of Date of Birth (i.e., SSC Board Certificate or Secondary School Leaving Certificate only).
 - (b) Certificates/documents in support of educational qualifications and experience.
